





NOTIFICATION

Whereas the minimum rate of wages for un-skilled, semi-skilled, skilled and highly skilled categories of employees in 89 scheduled employments were fixed/revised by the Government in Labour & ESI Department Notification No. 6502-LL-I(AR)-1/15/LESI dated the 30.10.2018 published in the Extraordinary issue No. 1991 of the Odisha Gazette dated the 30.10.2018 bearing SRO No. 431/2018;

And whereas, the State Advisory Board in its 52<sup>nd</sup> meeting have advised to adopt a system of Variable Dearness Allowances (VDA) @ Rs. 0.90 per point rise in the Consumer Price Index (CPI) Number for Industrial Workers (base 2001-100) as admissible shall be declared at half yearly, interval i.e. on 1<sup>st</sup> April & 1<sup>st</sup> October from the date of notification of revised wages, to be effected from 1<sup>st</sup> October, 2019.

Accordingly, the Variable Dearness Allowance @ Rs. 0.90 paisa per point rise in All India Consumer Price Index Number (Base 2001-100) needs to be effected from 1<sup>st</sup> October, 2019 for the points raised from the date of Notification of the revised minimum wages to 30<sup>th</sup> September, 2019.

Now therefore, I Sri Niranjan.Sahu, I.A.S, Labour Commissioner, Odisha in exercise of the powers delegated to me in the aforesaid Notification do hereby notify that the special allowance called as Variable Dearness Allowance @ Rs. 11.70 paise shall be payable per day to the un-skilled, semi-skilled, skilled & highly skilled categories of employees in all 89 scheduled employments (list enclosed) w.e.f. 01.10.2019 in addition to the minimum rate of wages notified vide Labour & ESI Department Notification No. 6502-LL-i(ar)-1/15/LESI dtd. 30.10.2018.

Accordingly, the present rate of minimum notified wages including VDA with effect from 01.10.2019 will be specified as under.
